



CHARLEVOIX PHOTOGRAPHY CLUB CALL FOR ARTISTS

Exhibition Dates: May 27 – June 24, 2016

Location: Charlevoix Circle of Arts Gallery

The Charlevoix Photography Club, Inc. (CPC) is pleased to accept submissions for its 8th Annual Fine Art Juried Photography Exhibition on Friday May 20, 2016 from 4:00 p.m. to 7:00 p.m. and on Saturday May 21, 11:00 a.m. to 2:00 p.m. at the Circle of Arts Gallery, located at 109 Clinton Street, Charlevoix, Michigan. To be eligible for the Exhibition, entries must be received, and the submission process completed, by 2:00 p.m. May 21.

Jeff Rabidoux, an outstanding photographer from Glen Arbor, Michigan, will jury the Exhibition. Mr. Rabidoux's approach to his photographic art and his experience in creating Michigan based images uniquely qualifies him to evaluate the art. The Exhibition is open to all Fine Art Photographic Images. These Images will be juried in three categories: People, Landscapes and Animals. Submissions are not limited as to date or location of creation. Recognition will be given for first, second, third, and two honorable mention Images in each category.

Submissions are subject to the following terms and conditions:

1. Payment of a non-refundable registration fee of \$40, for artists 19 years of age and older and \$20 for artists 18 years of age or younger.
2. The registration fee entitles an artist to submit two images. Artists may purchase up to two more submissions (for a maximum of 4 images per artist), for an additional registration fee of \$15 per image.
3. All art submitted must be on print media ready to hang.
4. At the time of registration the artist must complete and submit an entry form and deliver a digital copy of each submitted image in JPEG format with a resolution of not less than 300 pixels per inch. Digital images are to be titled as follows: artist's last name_title of image (i.e. Smith_birdsinflight). Submitted art will not be hung if registration process is not completed.
5. The registration form may be downloaded from our web site www.charlevoixphotographyclub.org
6. For each image registered the artist must provide (a) his/her election of category, People, Landscapes or Animals, (b) title of the image, (c) the dimensions of the ready to hang art, and (d) the sale price, or notice that the submission is not for sale (NFS).
7. Submitted art must be photographic in origin.

8. Artists may not be identified on the front of the artwork. Images may be signed after the show is judged.
9. Neither the CPC nor the Charlevoix Circle of Arts (including members, volunteers and employees) will be responsible for any damage to any art submitted. It is suggested that photographers carry separate insurance.
10. Art previously exhibited in a prior CPC Exhibition is not eligible for submission.
11. Artists will be notified by email in the event submitted art is not selected for the Exhibition and may pick up their artwork during normal gallery hours at any time prior to the Exhibition.
12. Art included in the Exhibition may not be removed from the Exhibition prior to June 24th, 2016.
13. Following the Exhibition, art may be picked up at CPC on June 25th between the hours of 10:00 a.m. and 3:00 p.m. Art not picked up will become the property of CPC to dispose of, as it deems appropriate.
14. CPC will retain a 40% commission on any work sold from the exhibition. Artists should price their artwork to include a 40% markup.
15. The submitting artist grants CPC permission to reproduce and publish invited entries for educational and promotional purposes.
16. Submitting art for exhibition constitutes agreement with all of these rules/requirements.

The opening reception will be held at Charlevoix Circle of Arts between the hours of 5:30 p.m. and 8:30 p.m. on Thursday May 26, 2016. The Exhibition Awards will be announced at the reception.
